The hybrid meeting will be held both in-person and by electronic means pursuant to the Government Continuity Ordinance adopted by the Middlesex Board of Supervisors on May 5, 2020 and re-adopted November 4, 2020. The Board of Supervisors members and a limited number of staff may meet in-person if they choose, adhering to the guidelines of social distancing and the wearing of masks. The public will not be allowed to attend in-person for these limited hybrid meetings, but will continue to have electronic access via Zoom, by both computer and phone.

Access to the meeting may be by either video or audio using the access information above, and public comment will be taken. **A meeting password will be required to access the meeting.** Contact [s.traner@co.middlesex.va.us](mailto:s.traner@co.middlesex.va.us) or call the County Administrator's Office at 804-758-4330, between 8:30 am – 4:30 pm, for the meeting password.

There are several ways to access the meeting and/or make public comment:

- Up to one business day prior to the meeting, public comments can be emailed to: [s.traner@co.middlesex.va.us](mailto:s.traner@co.middlesex.va.us), mailed to the Middlesex County Administrator's Office, PO Box 428, Saluda, VA 23149 or delivered to the Woodward Building Drop Box (County Administration Building) at 877 General Puller Highway. During the meeting, public comments will be addressed by the Chairman or his designee and read into the record.
- If you have a microphone on your computer, you can make comments through your computer. There is a raise-hand feature on the Zoom meeting page that allows you to raise your hand to make public comment. The moderator or Chairman can see your hand raised and the microphone will be unmuted so that you can make comments. **If you do not have a microphone on your computer and you wish to make comments, you will have to call into the meeting using the phone number information above.**
- If you call in by phone to comment, you can **press \*9**, which is the same as the **raise-hand feature** on the computer, and it will show that your hand is raised to make a comment. **When the Chairman calls on you, press \*6 to unmute your phone**, and make your comments.
- You must identify yourself and time limits are still in place (3 minutes per person)
